BSN EDGE Articulation Agreement

Trinity College of Nursing & Health Sciences of Rock Island, IL, ("Trinity") and **Augustana College** of Rock Island, IL ("Augustana") believe that a cooperative program benefits students by allowing students an opportunity to earn dual acceptance and enrollment at both institutions to earn a Bachelor of Science Nursing degree.

This agreement defines the Articulation Agreement between Trinity College of Nursing & Health Sciences and Augustana College for qualified students seeking to complete their general education coursework at Augustana College and the Bachelor of Science in Nursing (BSN) curriculum, Basic Option, at Trinity College of Nursing & Health Sciences. Students participating under this agreement will earn automatic acceptance at Trinity College of Nursing & Health Sciences when they are accepted to Augustana College with a planned pathway in nursing.

Agreement

The Articulation Agreement is designed to provide participating students with a specific pathway to meet degree requirements established by Trinity College of Nursing & Health Sciences for a Bachelor of Science in Nursing (BSN) degree at Trinity College of Nursing & Health Sciences. This agreement applies to high school students who are seeking acceptance to both institutions.

It is agreed and understood that each institution has the right and responsibility to make changes to its curricula and enrollment standards to maintain its academic integrity and meet accreditation standards. Such changes, if any, will be communicated to the other institution as they occur through the office of each institution responsible for implementing this dual degree program.

At the request of either institution, a meeting or conference will be held to resolve any problems and monitor progress under the terms of this Articulation Agreement.

Under the terms of this agreement, neither institution is obligated to make any payments of any kind to the other institution.

Trinity will provide or support a nursing advisor or coordinator for weekly in person or remote "office hours."

For students completing a baccalaureate degree at Augustana College, please see the articulation agreement that applies: BA/BSN-Accelerated Dual Degree Articulation Agreement, BA/MSN Dual Degree Articulation Agreement.

EDGE Program

The Early Degree Guaranteed Entry (EDGE) program offers an excellent opportunity for high school students to obtain acceptance to Trinity College of Nursing & Health Sciences and Augustana College before graduating from high school. Application to the EDGE program must be completed before the high school diploma is conferred. (See Appendix A)

Application Process:

Students will apply for this pathway through application to Augustana College. Upon acceptance to Augustana College, students meeting the above admission requirements for the EDGE program who are admitted to Augustana will receive automatic acceptance to Trinity College of Nursing & Health Sciences BSN program. Students must submit their deposit to Trinity College of Nursing & Health Sciences after (1) completion of at least 24 credit hours of general education courses at Augustana College, and (2) at least 1 year prior to admittance at Trinity College.

Academic Requirements

- 1. Admission: High School GPA \geq 3.20 on a 4.0 scale
- 2. Admission: Composite ACT \geq 22 or SAT \geq 1100
- 3. Admission: High School Algebra 2
- 4. The student must complete the required general education courses for the BSN degree Basic Option at Augustana College to be accepted as transfer credits to the Bachelor of Science in Nursing degree, Basic Option, at Trinity College of Nursing & Health Sciences.
- 5. For students not completing a baccalaureate degree prior to the BSN degree program, the following general education courses must be completed prior to the BSN curriculum.

Year 1:

BIOL 130: Molecules to Cells (Pre-Req for Microbiology)

First Year Inquiry 101 (English Composition I)

SOAN 101: Introduction to Sociology (Sociology)

CHEM 215: Molecular Nutrition (Nutrition)

BIOL 250: Genetics (Pre-Req for Microbiology)

MATH 130: Statistics for Health Professionals (Statistics) SOAN 102: Introduction to Anthropology (Anthropology) PSYC 100: Introduction to Psychology (Psychology)

Year 2:

BIOL 351: Anatomy (Anatomy and Physiology I)

COMM 101 Public Speaking (Oral Communication)

PSYC 216 Human Development (Human Growth and Development)

BIOL 343: Microbiology (Microbiology with lab)

BIOL 362 Human Physiology (Anatomy and Physiology II)

PHIL 103 Social Ethics (Ethics)

Humanities Requirement (Humanities Course TBA)

[Term Course (English Composition II)

Completing at least Algebra 2 is the norm for students entering Augustana. Students entering Augustana will be assigned a Math Index Score based on ACT/SAT Scores and high school coursework. This score must be sufficiently high to gain admittance to Math 130, i.e. testing out of Algebra II.

Exception: The student may elect to reserve one general education course for the first semester of nursing except for the following courses which must be completed before beginning nursing coursework: Anatomy and Physiology I, Anatomy and Physiology II, Microbiology with lab. Students may complete Anatomy and Physiology I, Anatomy and Physiology II or College Algebra at either Augustana College or Trinity College of Nursing & Health Sciences.

6. The student must achieve a minimum cumulative GPA of 2.75/3.00 in general education/pre-requisite coursework for admission to the BSN degree program. (See Appendix B)

Accreditation

Trinity College of Nursing & Health Sciences and Augustana College will ensure they maintain accreditation with the Higher Learning Commission regional accrediting body and ensure all operations will be in keeping with accreditation requirements of the two institutions.

Duration and Termination of Agreement

Trinity College of Nursing & Health Sciences and Augustana College agree this Agreement shall be in force the date of the signing of the Agreement and shall remain in force until modified or terminated in writing, following reasonable and mutual discussion by representatives of the two institutions.

Trinity College of Nursing & Health Sciences and Augustana College reserve the right to revise or eliminate programs and courses. Such changes will be communicated to the appropriate parties. This articulation agreement will be reviewed annually to ensure currency with each party's degree requirements and may be modified by attachment.

Either party may terminate this Agreement upon written notice to the Party, with at least 90 days advance notice. In the event of such a termination, any student already admitted into the BSN program, Trinity College of Nursing & Health Sciences under this Agreement will continue to apply the transferred pre-requisite courses and credits to the BSN program as specified in this Agreement provided the student continues to meet satisfactory progress toward their bachelor's degree.
